I request permission to take a driving safety course and under penalty of perjury, I attest to the truth of the following:

1. I certify that (a) I have a valid Texas driver's license/permit, or (b) I am active duty military and have not completed a Driving safety course or motorcycle operator's course in another state during the preceding 12 months, and,
2. That I am not charged with speeding 25 or more miles above the posted speed limit,
3. That I am not currently taking a driving safety course for another court,
4. That I have not completed a driving safety course within 12 months prior to the offense date on my citation,
5. That I have not completed a driving safety course not currently reflected on my driving record.

I hereby enter my appearance on the complaint of the above stated offense. I understand that I have a right to a jury trial. I hereby waive my right to a jury trial, and elect under art. 45.0511, CCP, to take a driving safety course.

I wish to plea: **GUILTY** or **NO CONTEST**
And waive my right to a jury trial or hearing by the court

I understand that I must present to the court the following with this request:

1. Proof of **valid Texas driver's license/permit** or military ID
2. Proof of **financial responsibility** pursuant to chapter 601, transportation code (automobile liability insurance)
3. **Payment of \$107.10** in the form of a **cashier's check or money order** made payable to **Elgin municipal court** (includes court cost of \$97.10 and nonrefundable fee of \$10.00). ****or \$132.10 (for offenses in a school zone)**
